Tēnā koutou e te ao pāpāho reo Māori

Tēnā tātou i ō tātou tini mate puta noa te motu, heoi anō rā ka poroporoākī ki a rātou, haere, haere, haere atu rā. Ka whakaaro ki ngā mahi rangatira, me ngā whawhai nui i tutuki i a rātou i ō rātou nei rā.

Ka huri ki a tātou te hunga ora e hoe nei i te waka whakaora ake i reo Māori, kei mua i a tātou tētahi kaupapa nui, arā, te whakatau ko wai te māngai ao pāpāho reo Maori ka noho ki te tēpu matua o Te Mātāwai.

E mahi tahi ana Te Whakaruruhau o Ngā Reo Irirangi Māori me Ngā Aho Whakaari ki te whakatūturu i te māngai. Hei te rā nei ka tūwhera ngā tono mō te tūranga pāpāho ki te Te Mātāwai. Nā reira, pēnā e pai ana koe ki te tono, pānuitia te tikanga kei raro iho nei.

Background and Position Description

Te Whakaruruhau o Ngā Reo Irirangi Māori (National Māori Radio Network) and Ngā Aho Whakaari (Māori in Screen Production NZ) are seeking to appoint a member representing media to Te Mātāwai.

Te Mātāwai is established under Te Ture mō Te Reo Māori 2016 (the Act). Te Mātāwai is an independent statutory entity charged with leading revitalisation of te reo Māori on behalf of iwi and Māori. The Board is comprised of seven iwi cluster members, four organisation members (including Education, Media, Community, Urban) and two members appointed by the Minister of Māori Development (the Minister).

Approximately \$3 million is set aside for operating costs, \$10m towards investment in homes and communities and \$1 million for research and evaluation. In addition, Te Mātāwai has an oversight role over Māori Television Service (appointing members, and approving the Statement of Intent) and makes nominations to the Minister for appointments to Te Taura Whiri and Te Māngai Pāho.

The current operating model for Te Mātāwai is organised around three key areas:

Te Matatū: strategy and influence

• Te Mātāuru: investment

Te Mātātupu: research and evaluation.

Te Reo Tukutuku – Pāpāho

In accordance with Schedule 4 of the Act, Te Whakaruruhau and Ngā Aho Whakaari are charged with selection (and any subsequent removal) of the member on Te Mātāwai representing broadcasting in the Te Reo Tukutuku cluster. In doing so, we must consider the overall purpose and functions of Te Mātāwai. Our two organisations are both committed to conducting a fair and transparent process to ensure that the candidate best suited to the role, as per the ideal applicant description outlined below, is appointed.

Ideal candidate description

The selection panel will have regard to the matters outlined in the Act including: Māori language proficiency, Māori language revitalisation, governance, community development, management, Māori culture and central government operations.

In addition, we would also emphasise the following skills and qualities:

- demonstrated awareness of challenges facing the Māori content creation community industry as it affects the delivery of te reo to our people
- an advocate for Māori media based on a proven level of skill in all or any of Māori media areas that could include but is not confined to emerging technology, multi-media platforms, cinema, animation and related technologies;
- capacity to communicate our sector concerns in simple terms specifically for our organisations at both board and national levels;
- ability to influence at Ministerial level through leveraging of established relationships;
- willingness to consistently maintain a working knowledge of broadcasting trends throughout the duration of the appointment,
- familiarity with all legislation relating to te reo Māori, broadcasting and digital;
- regular attendance at Te Mātāwai board meetings; and
- at least quarterly reporting to Te Whakaruruhau and Ngā Aho Whakaari meetings.

Next steps

We invite those candidates to apply with affiliation to Te Whakaruruhau and/or current membership of Ngā Aho Whakaari who consider they meet the desired requirements, would not be disqualified for appointment under s 30 Crown Entities Act 2004, and can spare the required time commitment.

Please submit a brief cover letter, and an up to date governance (non-executive) curriculum vitae for consideration. Applicants will be shortlisted and must be available for panel interview (in-person in Auckland or via Skype) on Tuesday 24 September.
